## VID21/2019 Eastern Maar People (VC2012/001) - Remaining application area

This description is an interpretation of the application area that remains undetermined following the determination of native title by the Federal Court of Australia on 28 March 2023 and 21 March 2024 for VID21/2019 Eastern Maar People (VCD2023/001 & VCD2024/001) and Federal Court Order dated 21 March 2024 to dismiss those areas identified within those orders.

# **External boundary description**

The remaining application area covers all the land and waters within the external boundary described as:

Commencing on the centreline of the Shaw River at Longitude 142.063314° East in the township of Yambuk, being a point on the external boundary of native title determination VID6004/1998, VID655/2006 Gunditjmara & Eastern Maar (VCD2011/001); then generally north easterly along the external boundary of that determination to the western external boundary of native title determination VID21/2019 Eastern Maar People (VCD2023/001), being a point on the western boundary of the Penshurst - Dunkeld Road reserve at Latitude 37.816826° South; then north easterly, generally south easterly, generally south westerly and generally westerly along the external boundary of that determination to intersect a buffer 100 metres seaward of the mean low water mark of the coastline that is south of the mouth of the Hopkins River at Longitude 142.508263° East; then generally north westerly, generally south westerly and again generally north westerly along a buffer 100m seaward of the mean low water mark of the coastline to the south eastern corner of the external boundary of Native Title Determination VID6004/1998, VID655/2006 Gunditjmara & Eastern Maar (VCD2011/001) at Longitude 142.063314° East; then north along the external boundary of that determination back to the commencement point.

## **Exclusions**

Any area within the external boundary described in Schedule 1 for the following native title determinations:

- VID6004/1998, VID655/2006 Gunditjmara & Eastern Maar (VCD2011/001) as determined by the Federal Court of Australia on 27 July 2011; and
- VID21/2019 Eastern Maar People (VCD2023/001) as determined by the Federal Court of Australia on 28 March 2023
