Information identifying the boundaries of:

- (a) the area covered by the application; and

- 41. The boundaries of the area covered by this application are as follows:

The application area covers all the land and waters within the external boundary described as: Commencing at the south western corner of R 34605 (Plumridge Lakes Nature Reserve), being a point on the boundary of native title determination application WAD348/2017 Nanatadjarra People (WC2017/003); then extending due west to the western boundary of an Unallocated Crown Land Parcel at approximately Longitude 123.141491° East, Latitude 29.715325° South, being a point on the boundary of native title determination application WAD348/2017 Nanatadjarra People (WC2017/003); then generally northerly, generally north easterly, generally south easterly, and westerly following the boundaries of that application back to the commencement point, further described as:

"...then generally northerly, westerly, northerly, easterly, again northerly, again easterly, again northerly, again easterly and again northerly along the western and northern boundaries of that Unallocated Crown Land parcel to the southern boundary of R 36271 (Yeo Lake Nature Reserve); then westerly, northerly, again westerly and again northerly along the boundaries of that Reserve and onwards, being the boundary of native title determination application WAD297/2008 Yilka (WC2008/005), to a southwest corner of native title determination WAD6004/2004 Ngaanyatjarra Lands (Part A) (WCD2005/002) at Longitude 123.996068° East, Latitude 27.790887° South; then generally north easterly, southerly and easterly along the boundaries of that determination, native title WAD6004/2004 B) determination Ngaanyatjarra Lands (Part (WCD2008/001) and again native title determination WAD6004/2004 Ngaanyatjarra Lands (Part A) (WCD2005/002) to the northwest corner of native title determination WAD6002/2002 Pilki People (WCD2014/005); then southerly along that determination boundary to the northern boundary of R 34720 (Neale Junction Nature Reserve); then again southerly to another northwest corner of that determination on the southern boundary of that reserve and again southerly to the southwest corner of that determination; then westerly to the south eastern corner of R 34605 (Plumridge Lakes Nature Reserve) and again westerly along the southern boundary of that reserve back to the commencement point."

- 42. In addition, the external geographical boundaries of the area covered by this application are clearly delineated and marked on the attached map at ATTACHMENT C.
- 43. For the avoidance of doubt, the application excludes any area subject to:
 - (a) Native Title Determination WAD 297 of 2008, WAD 498 of 2011, WAD 303 of 2013 Yilka and Yilka # 2 and Sullivan Family (WC2017/005) as determined by the Federal Court on 27 September 2017.
 - (b) Native Title Determination WAD 6004 of 2004 Ngaanyatjarra Lands (Part A) (WC2005/002) as determined by the Federal Court on 29 June 2005.
 - (c) Native Title Determination WAD 6004 of 2004 Ngaanyatjarra Lands (Part B) (WC2008/001) as determined by the Federal Court on 3 June 2008.
 - (d) Native Title Determination WAD 6002 of 2002 Pilki People (WC2014/005) as determined by the Federal Court on 2 December 2014.
