



NSD857/2017 Warrabinga Wiradjuri #7 (NC2017/001) Amended

External boundary description

The area covers all the land and waters within the external boundary described as

Commencing at Longitude 149.385411° east, Latitude 32. 9 84° South (being a point on the centreline of the Talbragar River) and extending generally south easterly, generally north easterly, generally easterly, generally southerly and generally south easterly along that river centreline and the centreline of Mona Creek to its junction with an unnamed creek at Longitude 149.7 1922° east; then generally south easterly along that unnamed creek to the intersection of the centrelines of two unnamed creeks at approximately Longitude 149.713 7 ° east, Latitude 32.161341° South; then south easterly to a point on the centreline of the Moulburn River at approximately Longitude 149.8175 4° east, Latitude 32.2 9916° South; then generally easterly, generally north easterly, generally south easterly, generally south westerly and generally easterly along that river centreline to its intersection with Baerami Creek; then generally south westerly and generally southerly along that creek centreline to its headwaters at approximately Longitude 15 5.235 ° east, Latitude 32.67618 ° South; then southerly to the intersection of the centrelines of two unnamed creeks at approximately Longitude 15 5.2369 ° east, Latitude 32.68931 ° South; then generally easterly along the centreline of that unnamed creek to its intersection with Martindale Creek; then easterly along that creek centreline to its intersection with the centreline of an unnamed creek at approximately Longitude 15 5.8361 ° east, then southerly along that creek centreline to its headwaters at approximately Longitude 15 5.7577 ° east, Latitude 32.74832 ° South; then north easterly to the eastern boundary of the Hunter River catchment area (also being a point on the northern boundary of the parish of Medhurst) at Longitude 15 5.81761° east; then generally north easterly and easterly along that catchment boundary (also being on the northern boundaries of the parishes of Medhurst and Alomorang) to Longitude 15 5.713636° east; then generally south westerly and generally southerly passing through the following coordinate points.

Then southerly to a point on the northern boundary of the Parish of Kindarun (also the northern bank of the Macdonald River) at Longitude 150.650396° East; then generally south westerly and generally southerly along that parish boundary to a northern boundary of Wollemi National Park; then generally south easterly and generally southerly along the northern and eastern boundaries of that national park to the north eastern bank of Putty Creek; then generally south easterly, generally southerly, generally south easterly, generally south westerly, again generally southerly and generally westerly along banks of that creek, Wollemi Creek and Colo River to its intersection with the eastern prolongation of the southern bank of Tootie Creek; then generally westerly and generally south westerly along that prolongation and southern banks of that creek to the southernmost corner of Lot 31 on DP751626; then westerly to a point on the eastern bank of Bowens Creek at Latitude 33.486282° South; then generally south westerly along that creek bank to its junction with an unnamed creek at approximately Longitude 150.366887° East; then generally south westerly along that creek to Longitude 150.341779° East; then north westerly to a point on the northern boundary of the Parish of Blackheath at Longitude 150.326941° East, Latitude 33.537906° South; then generally north westerly along that parish boundary to the eastern boundary of Parish Hartley; then generally northerly and generally north westerly along the eastern boundaries of that parish and the Parish of Lett to Latitude 33.499417° South; then south westerly to a point on Kangaroo Corner Creek at Latitude 33.501020° South; then generally southerly and generally south easterly along the centreline of that creek and along the centreline of the River Lett and onwards to the centreline of the Coxs River; then generally north westerly along the centreline of that river to the centreline of Jenolan Cave Road; then south westerly along the centreline of that road to the south western bank of the Cox River; then generally north westerly, generally westerly and again generally north westerly along the southern bank of the Coxs River to Lake Lyell; then generally north westerly along the former southern bank of the Coxs River to Latitude 33.508861° South; then generally north westerly and generally south westerly along the centreline of the eastern arm of Lake Lyell (Sandalls Creek) and the southern bank of Sandalls Creek to a point near its source at Latitude 33.531263° South; then north westerly to the southernmost corner of the Parish of Lidsdale at Longitude 150.012932° East (also being a point on the centreline of Antonio Creek); then generally north westerly and generally northerly along that parish boundary to the easternmost corner of the Parish of Thornshope; then generally north westerly passing through the following coordinate points.

Then westerly to a point of the eastern boundary of the Parish of Castleston at Latitude 33.387094° South; then generally northerly, generally north westerly and again generally northerly along eastern boundaries of that parish, southern and western boundaries of the parishes of Coolamigal, Turon, Dulabree and Sofala to Longitude 149.728452° East; then westerly to a corner on the western boundary of Parish of Wiagdon at Latitude 33.167977° South; then generally westerly and generally northerly and generally north westerly along that parish boundary and the southern boundaries of the Parish of Waterbeach to Longitude 149.619665° East; then generally northerly passing through the following coordinate points.

Then north westerly to the centreline of Little Oak Creek at approximately Longitude 149.286514° East, Latitude 32.671536° South; then generally north westerly along that creek centreline to the eastern shore of Lake Burrendong; then northwest to the western boundary of the Parish of Canning (centreline of Lake Burrendong) at Longitude 149.247552° East, Latitude 32.627794° South; then generally northerly along western and northern boundaries of that parish, Parish of Merinda, Parish of Rouse and Parish of Wiadere to a south western corner of the Parish of Yarrobil; then generally north westerly along the western boundaries of that parish and the Parish of Goolma to its junction with an unnamed creek (in the vicinity of Shearmans Bridge) at approximately Latitude 32.353088° South; then generally north easterly along the western bank of that unnamed creek to its source at approximately Longitude 149.297987° East, Latitude 32.320998° South; then north easterly to the shared corner of the Parishes of again Yarrobil, Goolma and Tuckland (on a southern boundary of Yarrobil National Park); then generally north easterly, generally westerly and generally northerly along the eastern boundaries of the Parish of Tuckland, southern and western boundaries of the Parish of Yarrow to the easternmost corner of the Parish of Blackheath at Latitude 32.122251° South; then generally north easterly and generally northerly passing through the following coordinate points.
