

SCHEDULE 6 – Other interests in the Determination Area

2. The rights and interests of the State of Queensland, Boulia Shire Council, Burke Shire Council, Cloncurry Shire Council, McKinlay Shire Council and Mount Isa City Council to access, use, operate, maintain and control the dedicated roads in the Determination Area and the rights and interests of the public to use and access roads.
3. The rights and interests of each of Boulia Shire Council, Burke Shire Council, Cloncurry Shire Council, McKinlay Shire Council and Mount Isa City Council:
 - (a) under its local government jurisdiction and functions under the *Local Government Act 2009* (Qld), under the *Land Protection (Pests and Stock Route Management) Act 2002* (Qld) and under any other legislation, for that part of the Determination Area within the area declared to be Council's local government area;
 - (b) as the:
 - (i) lessor under any leases whether separately particularised in this determination or not;

55. The rights and interests of the holders of any licences, permits or allocations under the *Water Act 2000* (Qld) and any relevant regulations or subordinate legislation made under that Act.
56. The rights and interests of members of the public arising under the common law, including but not limited to the following:
 - (a) any subsisting public rights to fish; and
 - (b) the public right to navigate.
57. So far as confirmed pursuant to s 212(2) of the *Native Title Act 1993* (Cth) and s 18 of the *Native Title Act (Queensland) Act 1993* (Qld) as at the date of this Determination, any existing public access to, and enjoyment of, the following places in the Determination Area:
 - (a) waterways;
 - (b) beds and banks of waterways; and
 - (c) areas that were public places at the end of 31 December 1993.
58. Any other rights and interests held by the State of Queensland or Commonwealth of Australia, or by reason of the force and operation of the Laws of the State or the Commonwealth.
