

## **SCHEDULE 1**

## **DETERMINATION AREA**

The Determination Area, generally shown as bordered in blue on the maps at Schedule 2, comprises all land and waters bounded by the following description:

All those lands and waters commencing at the southernmost southwestern corner of Native Title Determination WAD460/2018 Nangaanya-ku (Part A) (WCD2021/009) also being a point on the boundary of the Goldfields Representative Aboriginal and Torres Strait Islander Body (RATSIB) area boundary and extending generally southerly, westerly and generally southwesterly along the boundaries of that RATSIB area to the intersection with the southernmost boundary of the southwestern severance of Pastoral Lease N049526 (Pinjin); Then westerly and northerly along the boundaries of that severance to Latitude 30.281870 South; Then generally northwesterly and generally westerly through the following coordinate points:

Then westerly to a point within the Comet Vale Townsite at Latitude 29.940025 South, Longitude 121.126441 East; Then westerly to the intersection of the centreline of the Goldfields Highway with Latitude 29.939912 South; Then generally northwesterly along the centreline of that highway to the intersection with a southeastern boundary of Menzies Townsite also being a point on the present boundary of Native Title Determination WAD142/2018 Darlot (WCD2018/005); Then generally southwesterly, generally northwesterly and generally northeasterly along the boundaries of that native title determination to the intersection of a line joining the southernmost southeastern corner of Lot 35 as shown on Deposited Plan 238402 (Pastoral Lease N049822 (Nambi)) to the northern corner of Lot 21 as shown on Deposited Plan 220928 (Pastoral Lease N050241 (Melita)) with a line joining Latitude 28.789849 South, Longitude 121.799120 East and Latitude 28.786713 South, Longitude 121.811331 East; Then generally northeasterly through the following coordinate points:

Then northwesterly to the intersection of the southern boundary of Pastoral Lease N049714 (Erlistoun) with Longitude 122.085667 East; Then easterly and northerly along the boundaries of that pastoral lease to the intersection with the northeastern boundary of Dedicated Road No. 9468 (Erlistoun Road); Then generally southeasterly along the eastern boundaries of that dedicated road to the intersection with a northwestern boundary of Beria Townsite; Then northeasterly, southeasterly, again northeasterly and again southeasterly along the boundary of that townsite to the intersection with the centreline of the Great Central Road; Then generally northeasterly along the centreline of that road to the intersection with a southern boundary of Native Title Determination WAD297/2008, WAD498/2011, WAD303/2013 Yilka, Yilka #2 and Sullivan Family (WCD2017/005); Then easterly, southerly, again easterly, southeasterly, again southerly and again easterly along the boundaries of that native title determination to the intersection with a northwestern corner of Native Title Determination WAD460/2018 Nangaanya-ku (Part A) (WCD2021/009); Then generally southerly along the boundaries of that native title determination back to the commencement point.
