ORDER

JUDGE: Justice Finn

DATE OF ORDER: 23 August 2010

WHERE MADE: Adelaide (via videolink to Brisbane and Melbourne and telelink to Thursday Island)

THE COURT DETERMINES THAT:

1. The determination area is the waters described in Schedule 1.
2. Native title does not exist in the parts of the determination area described in Schedule 3.
3. Native title exists in those parts of the determination area described in Schedule 4 (native title areas).
4. (1) The group rights comprising the native title are held by the members of each of the following island communities in respect of the native title areas described in Schedule 4:
 - (a) Meriam (Mer);
 - (b) Erubam Le (Erub);

- (c) Ugarem Le (Ugar);
- (d) Masigalgal (Masig);
- (e) Porumalgal (Poruma);
- (f) Warraberalgal (Warraber);
- (g) Iamalgal (Iama);
- (h) Mualgal (Mua);
- (i) Badulgal (Badu);
- (j) Gumulgal (Mabuiag);
- (k) Saibailgal (Saibai);
- (l) Boigulgal (Boigu); and
- (m) Dauanalgal (Dauan).

(2) The native title holders are, in aggregate, the persons identified in Schedule 5(1).

5. The native title rights and interests are:

- (a) the rights to access, to remain in and to use the native title areas; and
- (b) subject to orders 6 and 9, the right to access resources and to take for any purpose resources in the native title areas.

6. No determination is made as to any native title right or interest in relation to access to or the taking of minerals and petroleum resources in the native title areas.

7. The native title rights and interests do not confer:

- (a) possession, occupation, use and enjoyment of the native title areas or any parts thereof on the native title holders to the exclusion of all others; or
- (b) any right to control the conduct of others.

8. The native title rights and interests are subject to and exercisable in accordance with the:

- (a) traditional laws and customs of the native title holders; and
- (b) laws of the State of Queensland and the Commonwealth of Australia including the common law.

9. Notwithstanding anything in this determination, there are no native title rights and interests in the native title areas in or in relation to:
 - (a) such minerals as are wholly owned by the Crown; or
 - (b) such petroleum as is wholly owned by the Crown.
10. The nature and extent of the other interests in relation to the native title areas are set out in Schedule 6 (**other interests**).
11. The relationship between the native title rights and interests and the other interests is as follows:
 - (a) the other interests co-exist with the native title rights and interests;
 - (b) the determination does not affect the validity of those other interests;
 - (c) to the extent of any inconsistency, the native title rights and interests yield to the other interests referred to in Schedule 6.
12. In this determination, including its schedules, unless the contrary intention appears:
 - (a) '**high water mark**' has the same meaning as in the *Land Act 1994* (Qld) except where it is defined otherwise to identify the seaward boundary of land in or in the immediate vicinity of the native title areas in any existing:
 - (i) determination of native title;
 - (ii) native title determination application that has not been finalised, in which case it has the meaning attributed to it in that determination of native title or native title determination application as the case may be;
 - (b) '**waters**' has the same meaning as in the *Native Title Act*;
 - (c) '**Native Title Act**' means the *Native Title Act 1993* (Cth); and
 - (d) '**Treaty**' means the *Treaty between Australia and the Independent State of Papua New Guinea concerning Sovereignty and Maritime Boundaries in*

the area between the two Countries, including the area known as Torres Strait, and Related Matters signed at Sydney on 18 December 1978.

13. In the event of any inconsistency between a line or area shown on the Map in Schedule 7 and a line or area described in any other schedule, the written description shall prevail.

AND THE COURT ORDERS THAT:

14. Within 12 months of the date of this order, the native title holders are to file and serve:
 - (a) a notice in accordance with section 56(2)(a) of the *Native Title Act* indicating whether the native title holders intend to have their native title held in trust by one or more prescribed body or bodies corporate; alternatively whether they intend to have one or more prescribed body or bodies corporate perform the functions in section 57(3) of the *Native Title Act*; and
 - (b) if the native title is to be held in trust - the name and the rules of the proposed prescribed body or bodies corporate and the written consent of the prescribed body or bodies corporate;
 - (c) if the native title is to be held by the common law holders with one or more prescribed body or bodies corporate to perform the functions in sub-section 57(2) of the *Native Title Act* - the name and the rules of the proposed prescribed body or bodies corporate.
15. In the event that in respect of any part of the native title areas there is no nomination within the time specified in Order 14 or such later time as the Court may order, the applicant is to forthwith apply to the Court for further directions.
16. Until such time as there is a registered native title body corporate in relation to a part of the native title areas any notices required under the *Native Title Act* or otherwise to be served on the native title holders, the native title claim group or the applicant may be served upon the solicitor for the applicant and the representative Aboriginal body for the native title areas, and such service shall be deemed to be sufficient.

17. In respect of the native title areas, application QUD 6040 of 2001 is not “finalised” within the meaning of s 190(4)(e) of the *Native Title Act* until a prescribed body corporate has been determined, in accordance with s 56(1) or s 57(2) of the *Native Title Act*, to perform the functions mentioned in s 57(1) or s 57(3) of that Act as the case may be in respect of all parts of the native title areas.
18. The applicant is granted leave to amend the definition of ‘high water mark’ in the native title determination application to conform with the definition in this determination.
19. Liberty to apply:
 - (a) in relation to Orders 14 to 17; and
 - (b) for the purpose of establishing the boundaries of the adjacent areas referred to in Schedule 2 Item (2).
20. The Respondents, Pende Gamogab, Peter Niwia Sawabbarri, Naga Bewani Resources Association, Robinson Gibuma and Frank Warapa cease to be parties to the proceedings.

THE COURT DECLARES THAT:

1. Kawoi Ausa Songoro and those he represents have not established that they have any customary rights and interests in the claim area which were acquired by descent from a Torres Strait Islander.
2. The Gamia Family has not established that it has any customary rights and interests in the claim area which were acquired by descent from a Torres Strait Islander.

SCHEDULE 1 – THE DETERMINATION AREA

[See Order 1]

The determination area comprises:

- (a) excepting the areas described in Schedule 2 - all of the waters on the seaward side of the high water mark within the external boundaries described in Part 1 of this Schedule and shown generally on the map in Schedule 7; and
- (b) all of the waters on the seaward side of the high water mark, but not the seabed or subsoil, exclusive of the territorial seas of Aubusi, Boigu, Moimi, Dauan, Kaumag and Saibai as defined in Part 1 within the external boundary described in Part 2 of this Schedule and shown generally in the map in Schedule 7.

Part 1

- (1) Commencing at the point of Latitude 10°33'30" South, at its intersection with the western boundary of the area the subject of proceeding QUD 266 of 2008 [a point west of the western entrance of Prince of Wales Channel], thence in a westerly direction along the parallel of Latitude 10°33'30" to its intersection with the meridian of Longitude 141°00'00", thence in a northerly direction to its intersection with the Fisheries Jurisdiction Line as described at Annex 8 to the Treaty, thence in a north-easterly direction along that Fisheries Jurisdiction Line to the point of Latitude 9°46'00" South, Longitude 142°00'00" East [recorded as point (d) in the description at Annex 8], and thence north-easterly along that Fisheries Jurisdiction Line to the point of Latitude 9°45'24" South, Longitude 142°03'30" East [point (e) at Annex 8]; thence in a north-easterly direction along the Seabed Jurisdiction Line as described at Annex 5 to the Treaty to the point of Latitude 9°42'00" South, Longitude 142°23'00" East [point (f) at Annex 5]; thence north-easterly along that Seabed Jurisdiction Line to the point of Latitude 9°40'30" South, Longitude 142°51'00" East [point (g) at Annex 5]; thence along the Fisheries Jurisdiction Line as described at Annex 8 to the Treaty as follows: north-easterly along the geodesic to the point of Latitude 9°40'00" South, Longitude 143°00'00" East [point (w) at Annex 8]; thence north-easterly along the geodesic to the point of Latitude 9°33'00" South, Longitude 143°05'00" East [point (x) at Annex 8]; thence east along the parallel of Latitude 9°33'00" South to its intersection by the meridian of Longitude

143°20'00" [point (y) at Annex 8]; thence north-easterly along the geodesic to the point of Latitude 9°24'00" South, Longitude 143°30'00" East [point (z) at Annex 8]; thence north-easterly along the geodesic to the point of Latitude 9°22'00" South, Longitude 143°48'00" East [point (za) at Annex 8]; thence south-easterly along the geodesic to the point of Latitude 9°30'00" South, Longitude 144°15'00" East [point (zb) at Annex 8]; thence south along the meridian of Longitude 144°15'00" East to its intersection with the parallel of Latitude 10°30'06" South; thence west along the parallel of Latitude 10°30'06" to its intersection with the boundary of the area the subject of proceeding QUD 266 of 2008; thence generally northwesterly, westerly and south westerly through Bramble Channel following the northern boundary of the area the subject of proceeding QUD 266 of 2008 to the point of commencement.

(2) TERRITORIAL SEA OF THE ISLANDS OF AUBUSI, BOIGU AND MOIMI

The outer limit of the territorial sea of the islands of Aubusi, Boigu and Moimi, being a continuous line—

- (a) commencing at the point of Latitude 9°15'43" South, Longitude 142° specified as Point 1 at Annex 1 to the Treaty;
- (b) running thence along the geodesics successively joining the points specified as Points 1 to 8 at Annex 1 to the Treaty, being Latitude 9°15'43" South, Longitude 142°03'30" East ("Point 1"); Latitude 9°12'50" South, Longitude 142°06'25" East ("Point 2"); Latitude 9°11'51" South, Longitude 142°08'33" East ("Point 3"); Latitude 9°11'58" South, Longitude 142°10'18" East ("Point 4"); Latitude 9°11'22" South, Longitude 142°12'54" East ("Point 5"); Latitude 9°11'34" South, Longitude 142°14'08" East ("Point 6"); Latitude 9°13'53" South, Longitude 142°16'26" East ("Point 7"); and Latitude 9°16'04" South, Longitude 142°20'41" East ("Point 8"); and
- (c) thence along a series of intersecting arcs of circles having a radius of three miles and drawn successively from the following points described at Annex 3 to the Treaty—


