External boundary description

The application area covers all the land and waters within the external boundary of the following areas described as:

AREA B

The area of land and waters bounded by the following native title determinations and native title determination application:

- External boundary of the Native Title Determination QUD6006/2000 Wulli Wulli People (QCD2015/009) determination
- External boundary of the Native Title Determination QUD6162/1998 Iman People #2 (QCD2016/005)
- Native Title Determination Application QUD311/2011 Wulli Wulli and Wakka Wakka Peoples (QC2011/005)

Further described as:

Commencing at a point on the southern bank of Cockatoo Creek at Longitude 150.363147° East and extending generally easterly and generally north easterly along the southern bank of that creek to its intersection with the southern bank of an un-named creek at Longitude 150.418823° East; then generally easterly along the southern bank of that creek to an eastern boundary of Lot 3 on Plan FT840 (being on a north western boundary of the Western Downs Regional Council); then generally southerly along the north western boundary of that Local Government Boundary to its intersection with the northern boundary of Lot 5 on Plan NT196; then generally southerly and generally westerly along the western boundaries of that lot, Lot 21 on Plan SP263821 and northern boundaries of Lot 22 on Plan SP263821 to Longitude 150.395049° East, Latitude 25.895584° South; then northerly back to the commencement point.

AREA C

Commencing at Longitude 148.799268° East, Latitude 25.476188° South (being a point on the external boundary of the Native Title Determination QUD6162/1998 Iman People #2 (QCD2016/005)) and extending generally southerly, generally south easterly and generally north easterly along the



southern external boundary of that native title determination to Longitude 150.018105° East, Latitude

Then generally south easterly, generally north easterly and again generally south easterly along the northern boundary of Lot 21 on Plan FT111, northern and eastern boundaries Lot 23 on Plan FT111 and eastern and southern boundaries Lot 25 on Plan FT111 to the intersection with the southern boundary of the Burnett River Watershed; then generally southerly and generally south easterly along that watershed to Longitude 150.389149° East.

Then generally south easterly, generally southerly, generally westerly, again generally southerly and generally north westerly to a corner on the southern boundary of the Dawson River Sub Basin Drainage Area at Longitude 149.768726° East, Latitude 26.400883° South passing through the following coordinate points.

Then generally northerly, generally westerly and generally northerly along that southern and western boundaries of that watershed to its intersection with the southern boundary of Lot 236 on Plan NPW490, being the southern boundary of Native Title Determination QUD216/2008 Bidjara People (QCD2014/002); then generally easterly along that native title determination to its intersection with a line joining Longitude 148.799268° East, Latitude 25.476188° South and Longitude 148.800085° East, Latitude 25.475540° South, being a point on the western boundary of the external boundary of Native Title Determination QUD6162/1998 Iman People #2 (QCD2016/015).

Further described as:

Then generally easterly along the ridgeline of the Carnarvon Range to Longitude 148.516363° East, Latitude 25.243812° South, then south easterly to the headwaters of the Dawson River at Longitude 148.522580° East, Latitude 25.248430° South; then generally southerly and generally easterly along the northern bank of that river to its intersection with a line joining Longitude 148.799268° East, Latitude 25.476188° South and Longitude 148.800085° East, Latitude 25.475540° South.

Then southerly along the external boundary of Native Title Determination QUD6162/1998 Iman People #2 (QCD2016/015) back to the commencement point.

- That area within the external boundary of Native Title Determination QUD6006/2000 Wulli Wulli People (QCD2015/009) as determined 13 August 2015
- Native Title Determination QUD216/2008 Bidjara People (QCD2014/002) as determined 21 February 2014
- QUD366/2008 Mandandanji People (QC2008/010) as accepted for registration 5 April 2017
- QUD311/2011 Wulli Wulli and Wakka Wakka Peoples (QC2011/005) as accepted for registration 03 October 2014
- QUD400/2012 Gaangalu Nation (QC2012/009) as accepted for registration 15 November 2012
- QUD550/2012 Gunmggari People #4 (QC2012/014) as accepted for registration 09 January 2015
