



ATTACHMENT B – DESCRIPTION OF BOUNDARIES

Wurundjeri

External boundary description

The application area covers all the land and waters within the external boundary described as:

Commencing at the intersection of Rail Street and North Mountain Road at Heathcote Junction, being a point on the northern boundary of the Wurundjeri Woi-wurrung Cultural Heritage Aboriginal Corporation, Registered Aboriginal Party (RAP) area; then generally south easterly, generally northerly, generally north easterly and again generally south easterly along that RAP area boundary to intersect the western boundary of the Gunaikurnai Land and Waters Aboriginal Corporation, RAP area; then generally easterly and generally south westerly along that RAP area boundary to the northern boundary of the Parish of Baw Baw, being a point on the northern external boundary of native title determination VID6007/1998, VID482/2009 Gunai/Kurnai People (VCD2010/001); then westerly, generally southerly, generally westerly and again generally southerly that determinations external boundary to Brigg Track, being a point on the boundary of the Gunaikurnai Land and Waters Aboriginal Corporation, RAP area; then generally south westerly along that RAP area boundary to the intersection of the Princes Highway and Buln Buln Road; then continuing generally south westerly along Buln Buln Road to Walker Drive; then generally south westerly and generally north westerly the passing through the following coordinate points:

Then north westerly to the eastern boundary of the Wadawurrung Traditional Owners Aboriginal Corporation, RAP area boundary at the mouth of the Werribee River; then generally north westerly along that RAP area boundary and river to Leonards Hill - South Bullarto Road, being a southern boundary of the Dja Dja Wurrung Clans Aboriginal Corporation, RAP area boundary; then generally easterly and north easterly along that RAP area boundary to Romsey Road, being a southern boundary of the Taungurung Land and Waters Council Aboriginal Corporation, RAP area boundary; then generally north easterly along that RAP area boundary to the Wurundjeri Woi Wurrung Cultural Heritage Aboriginal Corporation, RAP area; then generally northerly, generally north easterly and generally south easterly along that RAP area boundary back to the commencement point.

For the avoidance of any doubt, the application area excludes any areas subject to:

- Native title determination VID6007/1998, VID482/2009 Gunai/Kurnai People (VCD2010/001) as determined by the Federal Court on 22 October 2010;
- Registered Aboriginal Parties (RAP) area for Gunaikurnai Land and Waters Aboriginal Corporation;
- Registered Aboriginal Parties (RAP) area for Wadawurrung Traditional Owners Aboriginal Corporation;
- Registered Aboriginal Parties (RAP) area for Taungurung Land and Waters Council Aboriginal Corporation; and
- Registered Aboriginal Parties (RAP) area for Dja Dja Wurrung Clans Aboriginal Corporation.

- Parish data sourced from Department of Environment, Land, Water & Planning, March 2025.

Reference datum

Geographical coordinates are referenced to the Geocentric Datum of Australia 2020 (GDA2020), in decimal degrees and are based on the spatial reference data acquired from the various custodians at the time.

Use of Coordinates

Where coordinates are used within the description to represent cadastral or topographical boundaries or the intersection with such, they are intended as a guide only. As an outcome of the custodians of cadastral and topographic data continuously recalculating the geographic position of their data based on improved survey and data maintenance procedures, it is not possible to accurately define such a position other than by detailed ground survey.
