SCHEDULE A NATIVE TITLE CLAIM GROUP [see Act, s 61]

The names (including Aboriginal names) of the persons (the ***native title claim group***) on whose behalf the application is made or a sufficiently clear description of the persons so that it can be ascertained whether any particular person is one of those persons.

1. The native title claim group comprises the members of the Alapanpe, Angenty, Arnmanapwenty, Ngarnalkurru, Nguyu, Pawu, Tyarre Tyarre, Arlekwarr and Yinjirrpikirlangu landholding groups. Those persons, according to the traditional laws acknowledged and customs observed by them:
 - (a) have spiritual, physical and/or historical associations with the area described in Schedule B ("the application area") and are traditionally connected to the area through:
 - (i) descent from ancestors (including adoption) connected with the application area as described in paragraph 8(a) below; or
 - (ii) non-descent based connections as described in paragraphs 8(b) below; and
 - (b) hold the common or group rights and interests comprising the native title in the application area.
2. The application area is located in Anmatyerr, Kaytetye and Warlpiri territory. The common body of traditional laws acknowledged and customs observed by members of the native title claim group govern how rights and interests in land are acquired and who holds them in particular parts of this territory, including the application area. The nine landholding groups which together comprise the native title claim group constitute a community or group whose members hold the common or group rights comprising the native title over the application area as a whole.
3. The term "estate" is used to describe the land and waters associated with a landholding group – which is commonly named after a prominent site or place in the estate concerned. The nine landholding groups are ordinarily named after their respective estate areas. Each landholding group is associated with one or more estate areas, and is affiliated to the following parts of the application area:
 - (a) Alapanpe: south-central area
 - (b) Angenty: south-central area
 - (c) Arnmanapwenty: south-east area
 - (d) Ngarnalkurru: Ngarnalkurru estate – northern area, and shared interests in Wartanyiyi estate – north-central area
 - (e) Nguyu: central and southern areas
 - (f) Pawu: south-western area
 - (g) Tyarre Tyarre: north-eastern area



- (h) Arlekwarr: Wardingkurlangu estate – north-central area
- (i) Yinjirrpikirlangu: shared interests in Wartanyiyi estate – north-central area

Estates extend beyond the boundaries of the application area.

4. The estate groups are associated with the Anmatyerr, Kaytetye and Warlpiri languages. Under the traditional laws acknowledged and customs observed by members of the native title claim group rights in land are not acquired through membership of a language group. Accordingly, linguistic affiliation or language group identity is not necessarily indicative of a person's connection to particular land and waters.
5. Members of the native title claim group have been recognised as traditional Aboriginal owners of other land under the *Aboriginal Land Rights (Northern Territory) Act 1976* (Cth) and as native title holders under the *Native Title Act 1993* (Cth):

8. In accordance with the claimants' system of traditional laws and customs in relation to membership of a landholding group and the possession of rights and interests in land the native title claim group comprises all those persons who are:

(a) descendants (by birth or adoption, and subject to paragraph 14) of the following named ancestor ("the ancestor") of the landholding group (with prominent claimants identified and their relationship to the ancestor indicated in square brackets):

(b) accepted as members of one (or more) of the landholding groups by the senior descent based members of the groups on the basis of their non-descent connections to the estate.

9. The ancestors identified in paragraph 8(a) are the uppermost generations of the known ancestors of members of the native title claim group.

10. Under the claimants' system of traditional laws and customs a person can be recruited and recognised (by the senior descent based members of the group) as a member of a landholding group on the basis of non-descent connections to the estate. The non-descent connections that senior members of a landholding group have regard to when considering the recruitment of a particular individual are:

- (i) spiritual identification with and responsibility for an estate;
- (ii) conception and / or birthplace affiliation with an estate;
- (iii) long-term residence in an estate;
- (iv) close kinship ties, including intermarriage;
- (v) shared section / subsection and / or moiety affiliation;
- (vi) a more distant ancestral connection to an estate, for example, mother's father's mother;
- (vii) possession of traditional religious knowledge, authority and responsibility for an estate;
- (viii) authority and responsibility for shared Dreaming tracks and/or places of significance connected with an estate;
- (ix) seniority in traditional matters concerning the claim group and/or the estate;

and acceptance by senior members of the landholding group concerned.



11. The claimants' system of traditional laws and customs includes rules about succession. Where landholding groups are depleted or extinct, more distant descent connections or *company country* relationships—when geographically close areas share certain properties particularly Dreamings, subsection affiliations, songs and ceremonies, or sets of owners—are activated to recruit people to 'look after' the country, including knowledgeable elders from neighbouring areas. A lengthy period of 'looking after' country may result in the neighbouring landholding group succeeding to the country of the depleted or extinct group. Social acknowledgement, possession of local cultural knowledge and an existing nearby ancestral affiliation, are the underlying foundations for lawful succession to land. Additional information about these rules is contained in Schedule F.
12. There have been two instances of succession within the application area:
Wardingkurlangu estate: now succeeded to by Arlekwarr landholding group on the basis that the original group has no living members, shared Dreaming (*Tyap Atnyemayt* = Edible Grub), ceremonial affiliations, shared patri-moiety affiliation, shared subsection affiliation and nearby patri-estate location.
Wartanyiyi estate: succession on the basis that the original group has no living members and the neighbouring Ngarnalkurru and Yinjirrpikirlangu groups share social, ancestral and Dreaming track (*Wardapi* = Sand Goanna) interrelationships, ceremonial affiliations and nearby patri-estate location.
13. Under the claimants' system of traditional laws and customs, descent is the most important basis for the possession of rights and interests in land. Subject to individual circumstances members of the landholding group who are descended from one of the ancestors possess and transmit a wide range of traditional rights and interests.
14. Under the claimants' system of traditional laws and customs rights and interests in a grandparent's father's estate are inherited through all four grandparental lines. However, members of the landholding group with descent connections through father's father and mother's father are generally able to activate the widest range of rights and interests in relation to the estate.
15. Under the claimants' system of traditional laws and customs, the range of rights and interests in land possessed by members of a landholding group who are not descended from the ancestors depends on individual circumstances, including the nature and extent of their non-descent connections to the estate. Such rights and interests are usually limited to the individual and are not transmittable.
16. A number of members of the native title claim group are members of more than one estate group, for example, due to different grandparental links to multiple estates.
