2. In relation to the non-exclusive areas the native title rights and interests of the members of the Malyangapa native title claim group are the rights:

- a. to access, remain on and use the areas;
- b. to access and to take for any purpose the resources of the areas; and
- c. to protect places, areas and things of traditional significance on the areas.

3. The native title rights and interests are exercisable in accordance with, and subject to the traditional laws and customs of the native title claimants; and the laws of the State of New South Wales, State of South Australia, and the Commonwealth, including the common law.
